# **DOVER PREPARES FOR CALPINE POWER PLANT**

alpine is moving forward with the Garrison Energy Center and Dover is planning improvements to support the natural gas-fired power plant.

The new-generation natural gas plant has an estimated price tag of \$309 million, although the company has not released a dollar figure.

The Dover City Council has authorized staff to spend up to \$6 million on infrastructure improvements to support the power plant, according to City Manager Scott Koenig.

According to Koenig, improvements include water distribution system improvements, a new

water tower, a sanitary sewer pump station, some gravity sanitary sewer, some force main improvements and some street and stormwater improvements. The improvements are expected to be financed from an upcoming bond issue.

Also a part of the financial package is a state grant for \$2.5 million to help offset the cost of a gas line that would run to the property from the Cheswold area.

In his State of the State speech, Delaware Gov. Jack Markell said the Dover plant would aid efforts to produce more clean energy in the state.

# Calpine plans to expand power presence in Delaware

The *Dover Post* reported last week that ground could be broken for the plant this spring. Calpine earlier estimated that the plant would go online by June 2015.

Texas based Calpine operates a regional headquarters in Wilmington.

Electrical demand for Dover's city-owned electric utility is a little more than half of the peak capacity of the proposed plant. The plant site allows for a doubling of the 309 megawatt capacity, according to Calpine.

The feasibility of the plant got a boost from growing natural gas supplies in the region, as Marcellus Shale deposits are tapped in Pennsylvania. Natural gas prices, while historically volatile, have more recently become competitive with coal.

Drilling activity is slowing in Pennsylvania as energy companies wait for new pipelines and markets, according to an Associated Press story.

"When Calpine acquired Conectiv Energy in July 2010, we made a commitment to Delaware that we would be a good corporate citizen," said Jack Fusco, Calpine's CEO said in November of

last year. "Initially, we voluntarily eliminated the use of coal at our power plants in favor of cleaner burning natural gas. Our next step is to help Delaware ensure its electric energy supply future by constructing a modern, state-of-the art power plant that will provide competitively priced, reliable electric energy for the Delmarva Peninsula."

The Garrison Energy Center would operate as a combined-cycle, natural gas-fired generating facility. The project has received strong support from state and local officials.

"Delaware is committed to securing cleaner,

cheaper and more reliable energy," Gov. Jack Markell said in November. "By deploying advanced energy-efficient technology, electric production from the Garrison Energy Center will provide lower-cost and cleaner electricity for Delaware residents and businesses, while displacing older, inefficient and dirtier sources of energy from upwind states. Since Calpine established a regional headquarters in Wilmington two years ago, my administration has supported its efforts to help meet the state's power needs while creating jobs and spurring new economic development opportunities."

The project will also provide local benefits. "Calpine's Garrison Energy Center, which will be built in Dover's Garrison Oak Technical Park, represents a unique opportunity for the city. This state-of-the-art generating facility will improve the reliability of the electric system and provide new and much-needed revenue streams for the city. In addition, the construction of a pipeline to serve the facility will expand the availability of natural gas to other businesses and consumers in the region," said Dover Mayor Carlton E. Carey Sr. "

# PBF posts strong earnings as oil-rail plans move forward

Shares of the owner of the Delaware City Refinery surged after its first earnings report as a publicly traded company. The price settled back to \$39.33 on Monday.

PBF Energy Inc. posted fourth quarter operating income of \$284.9 million compared to an operating loss of \$165.6 million during the same period a year earlier.

Revenue for the year was \$20.1 billion compared

to \$14 billion a year ago. Revenue in the fourth quarter was \$4.95 billion, compared to \$4.8 billion a year earlier.

The results led PBF board to increase its dividend above the estimate used in its stock offering materials.

Stock in the company has traded at between \$26 and \$40 a share since it went public a few months ago.

New Jersey-based PBF owns the Delaware City Refinery, the focal point of the company's efforts to process crude oil brought in by rail from North Dakota and Canada. Delaware City has traditionally relied on tanker shipments from overseas. PBF says the rail shipments from an area where crude oil sells at a discount give PBF a cost advantage, even with added costs.

Analysts have questioned whether the strategy will work over the long term as new pipelines go into operation, but were reportedly more upbeat after the release of the earnings report.

Adjusted net income for the fourth quarter \$165.7 million compared to a loss of \$111.7 million for the fourth quarter 2011. The results reflect the conversion of securities into PBF common stock. For the year, operating income was \$920.4 million, compared to \$305.7 million for the same period in 2011. Adjusted net income for the year was \$492.5 million compared to \$146.9 million for the corresponding period in 2011.

PBF Energy's full-year results include a full year of operations of the company's refineries compared to 2011, which had 12 months of operations of the Paulsboro refinery, ten months of operations of the Toledo refinery and activities to reconfigure and restart the Delaware City refinery.

Delaware City went into full operation in the fall of 2011 after a lengthy start-up process that was partially the result of a full shutdown by former owner Valero. PBF bought its first refinery with the **Continued on next page**

help of a financial package that included participation by the State of Delaware.

Tom Nimbley, PBF Energy's CEO, said, "PBF's fourth quarter and full year results are reflective of our commitment to safety and our ability to run our refineries reliably and efficiently. During the fourth quarter, we were able to take advantage of positive market conditions and, importantly, we began to realize the initial benefits of our crude-by-rail strategy at our east coast refineries."

The company's 70,000 barrel per day track at Delaware City is now in full operation. Initial discharge rates indicate that this facility is capable of operating above its capacity of 70,000 barrels per day, a press release stated.

The board approved the recently announced expansion project to double the company's heavy crude unloading capability to 80,000 barrels per day by the fourth quarter of this year. Upon completion, PBF Energy will be able to deliver more than 150,000 barrels per day of crude oil directly into the Delaware City refinery via rail.

A portion of the community that contains townhouses is now open to residents of all ages, according to the village website.





# Innvovation center comes to Hercules building

Pollowing the completion of extensive renovations that have transformed the ground floor of Hercules, the partners of McConnell Johnson Real Estate are set to move onto the project's next phase: creating a destination.

With amenities such as their recently formed business incubator, a training, meeting and conference center courtesy of The Hub, and a full-service, upscale restaurant, Hercules is set to become a site for lunchtime excursions, business gatherings and an entrepreneurial environment, developers say.

Other amenities in the atrium will include a food court, a health and fitness center and a Wi-Fi lounge.

Phase 3 of the overall \$20 million project included \$2 million in upgrades to the building's systems and an all-new atrium. Built in 1983 as corporate headquarters for Hercules Inc., the 12-story landmark at 1313 North Market Street



has been converted into an office center suitable for multiple uses with attractions that will appeal to workers and residents of Mid-Town Brandywine.

"We're creating reasons for it to be a destination, not just an office building," said Scott Johnson, partner in McConnell Johnson Real Estate, manager and leasing agent for the building.

The business incubator, to be known as The McConnell Johnson Innovation Center, will appeal to startups in the mobile, finance and media

industries and to entrepreneurs seeking international connections, said Paul McConnell, CEO of McConnell Johnson.

"New incubation centers are opening every day around the world. We're enthusiastic about offering a new generation of business leaders a place where they can test and share ideas and develop the contacts they need to navigate the path to their prosperity," McConnell said. Space in the business incubator will be available in several desk configurations, McConnell said.

Innovation Center members will receive administrative support and access to technology essential for their businesses.

Innovation Center tenants already include Continuity Dynamics, a consulting firm that assists businesses with disaster recovery, and the nonprofit Film Delaware, headed by film industry veteran T.J. Healy, which works to attract and assist motion picture, television, documentary and video

# Glowing ticket sales reported for Firefly Festival

**Firefly Music Festival,** from June 21 to 23, is shaping up to be a much bigger event in Dover.

Buzz over last year's event appeared to trigger a buying panic for tickets, with ticket sales matching last year's total attendance in an hour or so.

Headlining the event are veteran bands, Red Hot Chili Peppers and Tom Petty and the Heartbreakers. More than 70 acts have been scheduled.

Some buyers of tickets were looking at a quick profit. Three-day passes were available on the StubHub website at a price \$100 or more above list.

The festival had estimated attendance of 30,000 last year, even though it was competing with other regional music events and the Delaware State Fair's entertainment offerings.

Higher attendance would fill up hotel rooms in central Delaware and perhaps beyond.

The volume of ticket traffic overloaded Amazon ticket servers and led to frantic and angry posts on the festival's website. By Friday night, some

Firefly fans were taking shots at the critics on Facebook. The problems were resolved, but discount tickets are gone and only the highest priced general admission and VIP passes remained as of the weekend.



Another glitch popped up when the festival announced that one well-known band, Imagine Dragons, could not appear, due to a scheduling conflict. The group will be replaced by Jim James, of the band My Morning Jacket.

The festival issued the following on Facebook on Friday night:

"Hey Firefly Fans. We know many of you experienced some delays and frustrations during the first couple ticket buying hours yesterday and we apologize for this. That's not how we want any part of your Firefly experience to be. We're always working to ensure you have a great experience leading up to, during and after your weekend at The Woodlands. We can't thank you enough for your support and

patience as we got through some growing pains yesterday! It was truly an epic day in Firefly history."

Total ticket sales numbers so far this year were not released.

The festival is being presented by Chicago-based Red Frog Events. The company partnered with Dover Motorsports, which owns The Woodlands. Until Firefly, Redfrog was best known for managing large-scale running events.

Last year, Dover Motorsports gained rental and concessions revenue from Firefly. Firefly features upscale food offerings, craft beer and even balloon rides.

Red Frog is also a supporter of St. Jude's Childrens Hospital in Memphis, with some proceeds from the event going to the hospital that is associated with the late entertainer Danny Thomas. His family remains a strong supporter of the hospital.

# Delaware bill ties pay to cost of living increase formula

he Delaware General Assembly will once gain hash out an increase in the minimum wage. Senate Bill 6 would increase the minimum wage to not less than \$8 an hour effective July 1, 2013 and not less than \$8.75 per hour effective July 1, 2014.

If the federal minimum wage becomes higher than the Delaware minimum wage, the Delaware minimum wage would increase by \$1 above the federal minimum wage.

In addition, effective July 1, 2014, the minimum wage would increase by a percentage equal to the percentage of Cost of Living Adjustment (COLA) as determined periodically under the federal Social Security Act.

Sen.Robert Marshall, D-Wilmington, is sponsoring the legislation that passed the Senate, but died in the House last year. The legislation is getting more attention this year after President



Barack Obama called for an increase in the minimum wage and a cost of living adjustment.

In Delaware and throughout the nation, any plan to increase the minimum wage faces opposition from the business community.

The argument often centers on the minimum wage boosting all wages during a slow economic recovery.

Workers earning that wage counter that they end up working more than one job as employers that do offer benefits work limit full-time positions.

Another worry is the phase in of the Affordable Care Act that will require some smaller companies to offer health insurance.

The National Federation of Independent Business issued a press release more than a month ago opposing the increase. "Delaware has the best reputation in the northeast as a place to do business and this legislation puts that at risk," said Ellen Valentino, state director for the NFIB. "All the credible research shows that higher minimum wage laws hurt small employers and cost jobs."

She said that Delaware small businesses will react to a higher minimum wage by cutting hours for their employees, automating certain jobs or simply finding ways to avoid hiring.

"Small businesses can't increase their sales by 10 percent by waging a magic wand" said Valentino.

# Business center helps pub get off to good start

cTullio's Pub sits just a parking lot away from the Pennsylvania state line, but its location in Delaware gave owner Barbara Tullio access to an invaluable resource in the Delaware Small Business and Technology Development Center (SBTDC).

She had been working at Roy's Pourhouse, a small tavern at Tri-State Mall in the northeastern tip of Delaware, for about five years when the owner admitted that he was having financial difficulties. He offered her a partnership in the business and three months later asked her to buy him out.

"I had always thought it would be wonderful to have my own place," Tullio says, "so I jumped at the chance." But Tullio was so successful at attracting — and keeping — customers that the business quickly outgrew the small space.

A larger store just a few doors north in the shopping center was available for lease, but Tullio was operating from month to month financially and lacked the capital to renovate the space and launch a larger business.

Enter Wendy Wen, SBTDC business analyst.

"Barbara was referred to us by Ken Anderson in the <u>Delaware Economic Development Office</u>," Wen says. "Ken described Barbara's existing business as 'thriving,' but he was also aware of the many challenges she faced in getting a loan, including a difficult private sector loan market, a short window of time to develop a business plan, and only two years of financials."

Wen put Tullio on the fast track to expansion by finding her an example business plan to use as a model, showing her how to do a cashflow projection, and linking her to First State Community Loan Fund (FSCLF), a non-profit that provides loan capital to small businesses, community organizations, and developers of affordable housing.

After several months of hard work dealing with plans and permits, contractors and computer software, Tullio opened the doors at her new location on Sept. 28, 2012. Within days of celebrating her grand opening, however, she was in a car accident and then was diagnosed with lung cancer.

But even as she recovered from the accident and underwent chemotherapy, the bartender-turned-businesswoman moved forward with her plans to take McTullio's from a tiny tavern with steamtable food to a pub with a real menu. The venue now offers live music, dart and pool leagues, chair massage, karaoke, and dance parties. Tullio has also hosted fundraisers for groups serving wounded warriors, children, and the homeless.

She is most proud of her contribution to the local labor market. "I've created eight jobs," she says in amazement. "Eight people have jobs because of this pub."

All of the pub's current employees are female, but **Continued on next page**

Tullio is an equal-opportunity host. Purse hangers on the bar make women feel welcome, while diamond-plate wainscoting on the walls reminds male patrons of their pickup truck toolboxes.

"We have a wide range of clientele, "Tullio says,

"and my only rule is that everyone has to treat everyone else with respect."

"Everyone here is family," she adds. "There's a lot of love in this place."

That love extends to Wen and everyone else who helped Tullio reach her current level of success.

"I love Wendy," she says. "She not only shared her knowledge with me but also gave me the gift of her patience. She spent time with me, shedding light on what I needed to do and walking me through the process. Most of all, she believed in me when I wasn't even sure I believed in myself."

Wen is quick to throw the credit back at Tullio. "Barbara is the hardest-working person I know," she says. "She is so committed to this business, and I know that she will do whatever it takes to succeed."

Tullio is also very grateful to Bob Kauffman and Phyllis McCollum, her loan officers at FSCLF. Like the patrons of her pub, the two have become Tullio's friends.

"I couldn't have done it without them," she says.

"They found creative ways for me to meet the requirements so that my loan would be approved.

I'm determined not to let them down."





# End of the road for financial charter high school

# Pencader struggled with many issues since founding

fter years of problems, the State Board of Education voted to revoke Pencader Business and Finance School's charter at the end of this academic year.

The board had placed the New Castle high school, which still was on probation from 2011 problems, on formal review in September 2012. This was the fourth time the school was placed on formal review since it opened in 2006.

Charter schools receive per pupil funding from state and local sources, but have to come up with capital funds for buildings and start up costs. Pencader suffered from financial and administrative problems throughout its existence despite much optimism about its curriculum at the outset.

The Charter School Accountability Committee's final report, outlines the governance, administrative, academic, financial and other problems cited by the committee in its recommendation to revoke the charter. The most successful charter schools have had strong support from the corporate sector,

parents or patrons.

Secretary of
Education Mark
Murphy considered
the committee's
findings as well as
transcripts from
two public hearings
and other submitted
comments and
documents before
recommending to the
board that it revoke



the charter. In his recommendation, Murphy noted that Pencader has no detailed plan to attract strong leaders to the school and failed to establish student performance goals, expectations and educational outcomes. The board voted 6-0 to revoke the charter.

"Charter schools are granted autonomy in exchange for accountability, and we will continue to hold all charter schools accountable for results to ensure they offer all students a high-quality education and an equal opportunity to succeed," said State Board Vice President Jorge Melendez, who chaired the meeting in State Board President Dr. Teri Quinn Gray's absence.

Murphy acknowledged the concerns of Pencader

families and other supporters who will be losing a school they supported. Many spoke at two public hearings earlier this month.

"Our priority in the coming weeks will be to work with families and accepting districts and charter schools as Pencader students and their parents determine their best educational options for next year," Murphy said. "We know this is a tough time, and we will work to facilitate the transition as much as possible."

In addition to their district feeder pattern schools, the students also may apply for schools through the state's Choice program. While the Choice application deadline was in January, the closure of their school is considered "good cause" under the law to allow the students to participate.

State officials will set up a meeting with Pencader families for within a week to explain next steps in choosing and enrolling in another school.

Representatives from district high schools will be invited to attend as well. The state expects full support from the accepting districts and will work together with their leadership to do what is best for these students. The state also will be setting up a designated email address and hot line for help. The state will announce the details as soon as they are finalized.
