



# CORPORATE DOWNSIZING PUTTING PRESSURE ON OFFICE VACANCY RATE

**orporate-owned** office space continues to move into the office leasing market as big employers restructure their operations.

That was the message coming from the third quarter report Wilmington area office report of Newmark Grubb Knight Frank. The firm has an office in Wilmington. <u>Click here</u> for the full report.

The latest example, according to the firm, took place when AstraZeneca sold the 195,000-square-foot building at 2200 Concord Pike, commonly known as the Rollins Building, to Roch Management, Inc., an investment firm controlled by the founder of Applied Bank.





The former Rollins Building is now on the leasing market.

The sale by AstraZeneca for \$10.5 million was the largest transaction. Applied was founded in Delaware as a credit card bank and operates a full service bank in the state with branches in Newark and Rehoboth.

The entire Applied building is currently available for lease. In addition, AstraZeneca is now marketing a two-building, 357,551-square-foot portfolio on its south campus for sale as the company reduces its Wilmington staff by 1,200.

"This phenomenon of corporateowned assets adding to vacancy is not
a new one for the greater Wilmington
area," said Neal Dangello, NGKF
senior managing director. "Fortunately,
the legal and financial services
sectors are showing signs of positive
momentum as of late. These sectors
have tallied 400,000 square feet of
positive absorption since 2012. This
is a hopeful sign for our market as law
firms and banks are the largest office


occupiers in the region."

Still, if the AstraZeneca and Applied office space is added in the county could see its office vacancy rate increase from 19.2 percent in the third quarter to more than 31 percent. The AstraZeneca space will be vacated in the next year or so.

Also on the office leasing market, at least on a short-term basis, are DuPont Co. buildings at Barley Mill as the company builds new office space at Chestnut Run. Plans by Stoltz to convert the Barley Mill site to a mixed use project have been stalled by a court decision over zoning.

"Looking forward, rents will soften amid the backdrop of persistently high vacancy," said Wills Elliman, senior managing director. "Vacancy increases are largely a result of additions to supply rather than demand deterioration as employment gains in traditional office occupying sectors showed signs of growing, albeit slowly, as of late."

# State, engineering companies settle Indian River Bridge suit

he Delaware Department of
Transportation announced that it
has resolved legal action involving
the placement and removal of roadway
embankments for the Indian River Inlet Bridge.
The lawsuit was scheduled for a 12 week trial
beginning in May, 2014.

The resolution, which arose out of voluntary mediation among the parties, requires the payment of \$5.25 million to the state. These funds must be applied to transportation projects for which federal funds may be used. The original suit was for \$20 million. Both MACTEC and Figg deny responsibility. While DelDOT, MACTEC and Figg all had experts prepared to testify in support of their claims and defenses, the uncertainties of litigation led to the compromise reached to resolve the litigation, a DelDOT release stated.

Problems that included the bridge project and real estate buying practices led to the departure of former DelDOT Secretary Carolann Wicks.

"This settlement allows DelDOT to receive



more than \$5 million for Delaware's taxpayers now, while avoiding the burdens and uncertainty of a lengthy trial involving complex geotechnical engineering issues next spring," said Secretary Shailen Bhatt. "This was a challenging case with strengths and weaknesses on all sides. I believe the settlement provides a reasonable resolution to this matter, and I look forward to applying the proceeds to help meet Delaware's transportation needs."

The bridge presented a number of engineering challenges, given its location in an area where the earlier bridge needed replacement, due to scouring action.

### Two more solar projects developed in New Castle County

olar panels are becoming part of the northern Delaware landscape. DuPont Co. is seeing solar cells on a site it owns along the Christina River in Newport as a Wilmington project nears completion.

The Newport site had earlier been remediated by DuPont, which operated in the area for many years.

DuPont spokesman Terry Goodling said the project is being developed by Tangent Energy and owned by Greenwood Energy will provide solar power for the area.

The solar panels are being supplied by DuPont Apollo Ltd., a wholly-owned subsidiary of DuPont

DuPont plans to announce further details following the project's expected completion at the end of November."

Meanwhile, New York-based Greenwood Energy, earlier this year, has completed the purchase of approximately two megawatts in capacity of solar projects in Wilmington.

The 'Peninsula' projects, each approximately 1 megawatt in size, were originally developed by



Tangent Energy Solutions, Inc., Kennett Square, Pa. The projects are nearing completion.

The Peninsula solar installations, built on about seven acres of remediated brownfield area, will sell power to Delmarva Power.

Remediation sites are viewed as good candidates for solar cells, since the areas are not suitable for other types of development and solar cells do little to disturb the area.

Solar projects have been aided by state mandates that will lead to a quarter of all electric power in the state coming from alternative sources.

The lion's share of solar energy generation has gone online in Kent and Sussex counties.

Other solar arrays upstate are in Delaware City and at an AstraZeneca complex now up for sale.

Delaware also is the home manufacturing site for Taiwan-based Motech. Motech solar cells have been used in other solar projects in the state, including Delaware City. - *Doug Rainey*

### High-speed data access point opens in Wilmington

he State of Delaware and <u>IPR</u> announced the launch of the Wilmington Network Access Point located in Wilmington at the 1201 N. Market Street office building.

The access point will provide connections from Wilmington to Philadelphia, Georgetown, Del., and Baltimore via more than 400 strands of dark fiber.

This new statewide network facility is a result of a \$3.5 million grant from the State of Delaware Infrastructure Fund, the first of its kind in the state. The state sees the dark fiber as a way to bring more technology-based businesses to the state while tying together its operations.

"This will not only provide residents of Delaware, whether individuals or businesses, with price-competitive bandwidth in the future, but will also enable state government to connect its offices throughout Delaware," said Tami Fratis, CEO of IPR. "And the most important aspect to all of us is the fact that the Wilmington NAP will help attract new businesses evaluating the pros and cons of relocating to Delaware. That's because this facility will effectively reduce the overall cost of network access to all businesses in Delaware."

IPR conducted the ribbon-cutting ceremony to launch the Wilmington NAP prior to its corporate board meeting. The launch of the Wilmington NAP is a large focus for IPR, as well as its partners -- Sunesys, Fibertech Networks, the City of Wilmington and McConnell Johnson Real Estate. Sunesys and Fibertech Networks are the providers building this fiber capacity; both were chosen due to their carrier-neutral relationships.

Fratis said the "Wilmington NAP" will be a catalyst in enabling Delaware to compete with larger urban areas (Philadelphia, New York, Baltimore and Washington, D.C.) in attracting businesses, individuals and jobs.

global law firm or an office for a large corporation, there is a need for significant bandwidth to access global data through the fiber infrastructure being brought in to the Wilmington NAP," Fratis said.

Meantime, IPR has added capabilities to the Wilmington NAP, including a 10GB (Gigabyte) lit services from two additional fiber providers - Windstream and Comcast Business. The lit fiber services are in addition to those carriers that IPR has already brought in to provide clients with lit

fiber services (Zayo Bandwidth, Verizon Business, Verizon and Level3), all within IPR's Wilmington center.

According to a release, IPR and its partners will conduct a series of marketing and educational events to put the Wilmington NAP on the "map" for those businesses seeking a Tier III+ data center facility & cloud solutions with the largest amount of data center space and highest amount of network bandwidth available in the Mid-Atlantic region.

### River & Bay signs 2nd brewery lease

Delaware River and Bay Authority officials announced that an agreement has been signed with the principal of Glasstown Brewing Company to lease a building at the Millville Airport in southern New Jersey.

The Authority Commission unanimously approved a Resolution, which authorized the lease of a former maintenance facility to the start-up brewer, at its September monthly meeting. The brewery plans to have visitor tours, a retail outlet

and tasting room at its new 2,800 square foot facility located at 10 Peterson Street.

The Glasstown Brewery is the second microbrewer to lease space at one of the agency's airports. Beginning its operations at the Cape May Airport in 2011, Cape May Brewing Company has expanded its production from 60 barrels that first year to about 1,500 barrels in 2013. Today, the company has ten year round employees.

## Aging population, recent recession play role in transfer payment jump


ver the past 20 years transfer payments (e.g., Social Security, Medicare, Medicaid, unemployment) have jumped from 10% to 20% of Delaware's personal income. This trend has been accelerated by the recent recession. Since 2008 Delaware personal income has increased 3% per year. Wages and proprietors' earnings have risen just 2.2% each year, dividends, interest and rent by 1.3% and transfer payments have risen by a whopping 7.6% a year.

Social Security accounts for more than one-third of Delaware transfer payments. This reflects the rapidly growing senior population in Delaware due to the aging baby-boomers and in-migrating seniors to southern Delaware.

Otherwise, the fastest growing segments of transfer payments include Medicaid and Supplemental Nutrition Assistance (food stamps). This parallels the drop in per capita income in Delaware to a figure below the national average, a rising poverty rate, and an increase in income inequality.

Finally, almost all transfer payments are indexed to inflation. This will

constrain the future rate of growth of personal income in Delaware. It will also mean that decisions in Washington, D.C. play a larger role in Delaware's economy.

The implications of this change in the composition of Delaware personal income on Delaware businesses varies by industry.

- For construction and real estate the disproportional increase in lower income households will drive demand for apartments and manufactured homes, and strain the limited stock of public and Section 8 housing.
- In financial services the growing population of lower income households will boost mortgage and consumer loan delinquency rates, overdue credit cards, and demand for payday loans. Financial literacy programs will be needed to encourage lower income households to use banks at all.
- The direct deposit of monthly Social Security payments will soar.
- The health care industry faces some of the greatest impacts. Medicare and Medicaid comprise almost half of all Delaware transfer payments.

This \$4 billion equals households account for a disproportionate share of emergency room visits and unpaid health care bills.

The rising bifurcated income distribution means that retail demand for discount goods through big box stores (e.g., Walmart), including groceries, will not abate. Increasingly, retailers will be torn between the more affluent and less affluent consumer markets. The overall slow growth in wages will continue to fuel consumers' search for the best prices using the Internet.

### Former executive pleads guilty in 401K theft case

A former executive of a Delaware development firm has pleaded guilty to charges of stealing from an employ 401K pension plan.

Michael A. Stortini – the managing member of the Frank Robino Companies, a real estate development company in the Wilmington area, pleaded guilty yesterday before United States District Court Judge Richard G. Andrews to charges of Theft from an Employee Pension Benefit Plan and Willful Failure to Pay Over Tax. Sentencing has been scheduled for March 11, 2014.

According to prosecutors, in 2009, Stortini diverted more than \$600,000 in funds from an employee 401(k) account to pay business expenses associated with the company.

Also in 2009 and 2010, Stortini failed to pay over \$450,000 in payroll taxes to the Internal Revenue Service for entities related to the Robino company. Stortini transferred more than \$900,000 from company accounts for his personal use, prosecutors stated.



### **Economic development focus of annual luncheon**

Gordon sees need for action in turning around county

Gordon made it clear that he does not see the glass as half full when it comes to the economy in New Castle County.

In brief remarks, Tuesday, at the annual luncheon of the New Castle Economic

Development Council Gordon said the county's economy is in poor shape and in need of attention.

He pointed to recent reports showing Delaware with low economic rankings.

Gordon said his administration plans to come up with an economic development plan that identifies the county's strengths. The county tax base depends on property taxes, transfer taxes and building permit fees. All are tied to some degree to the performance of the economy.

Gordon has ordered a reduction in impact

fees in an effort to encourage more new home construction. The fees are used to help pay for county services to new properties.

During his first time around as County Executive, Gordon provided funding for the council, which is also supported by around 30 businesses. The council affiliated with the New Castle County Chamber of Commerce. The chamber also operates a business incubator that nurtures and provides space for young businesses.

More optimistic about the future is Rick Deadwyler, who recently took a management position at the University of Delaware after a career at DuPont.

The former UD basketball star said it is an exciting time for the county economy, taking note of the university's STAR campus, the new home of the Bloom Energy manufacturing site and the proposed Data Centers project.

Deadwyler did not mention the Data Centers by name, but New Castle County Chamber President Mark Kleinshmidt did. He said the project would provide a big boost for the economy.

said Delaware needs to do a better job of talking about the innovations that have come out of its research.

Among the innovations that have come out of the state are Gore-Tex fabric, the touch technology in iPhones and DuPont's Corian counter material, Freschman said.

More important than tax and spending policies is the ability to attract entrepreneurs who come up with new technologies that create wealth, Freschman said.

Freschman founded Early Stage East, a venture capital fair that has raised more than \$1 billion in funding during its existence.

Freschman introduced keynote speaker Jennifer Hill, a lawyer and small business expert, who also focuses on issues related to female entrepreneurs.

Hill talked about a changing community that can now operates worldwide and the rise of "crowd funding" sites such <u>Kickstarter</u> and <u>Indiegogo</u>. The sites allow young companies to raise funds from a community of investors.

Hill would also like to see more skill hubs with concentrations of software writes and other technology professionals.

### Baetjer named acting head Tower Hill

arry Baetjer was named Acting Head of <u>Tower Hill School</u>, following an investigation involving Christopher Wheeler.

The announcement came in a letter from Earl J. Ball, III, chair of the board of the private school.

Baetjer has served Tower Hill in teaching and administrative capacities for more than 43 years. After teaching and coaching middle and upper school students, he became the Dean of Students in the Upper School in 1981, and four years later was appointed Head of the Upper School, Ball wrote.

Since 2008, he has been the Associate Headmaster of the school, managing many of the day-to-day operations. He is the father of three Tower Hill graduates. He has a bachelor's degree from Trinity College in Connecticut and has an M.A. from the University of Delaware.

"I have known Harry's work for more than

a decade. His reputation for dedication and integrity is well-earned and time-tested. The Board is grateful to Harry for assuming the role of Acting Head. I believe the students, faculty, parents and alumni who have worked with him will share that enthusiasm," Ball wrote. Ball is the retired head of Penn Charter School in Philadelphia.

Wheeler resigned this week after an investigation into allegations of child abuse led to a search of his office and home at the school. He has not been charged and the News Journal reported the matter did not appear to be tied to current students at the school.

Tower Hill has become known for the ability of its graduates to be placed into be placed into ivy league schools.

Graduates include TV host/physician Dr. Oz; current DuPont CEO Ellen Kullman; former Cong Mike Castle and U.S. Sen. Chris Coons. Kullman is on the board of the school.

### Price at the pump drops below \$3.25 a gallon

ould we see \$3 a gallon gas again? The jury is out, but the price at the pump dropped toward \$3.20 a gallon in Delaware and Maryland's Eastern Shore. In its weekend report, Wilmington-based AAA Mid-Atlantic reported the national average price for regular grade gasoline dropped to \$3.32. This price is four cents lower than one week ago, 13 cents less than one month ago and 28 cents less than the same day last year.

A quick check of prices on Sunday posted by AAA Mid-Atlantic many stations below \$3.25 a gallon, with a couple of stations in neighboring Elkton, Maryland coming in at \$3.20. This comes despite the fact that gas taxes are higher in Maryland. As of Wednesday one station in Bear was charging \$3.17 and another on Maryland Avenue was a penny below that figure. AAA noted that the last time the national average registered less than \$3.34 per gallon was January 22, when prices later rose nearly 59 cents in 41 days toward a 2013 high of \$3.79 per gallon on February 27.

After nearly 16 straight weeks (since July 2) above \$100 per barrel, the price of crude oil dropped below the triple-digit threshold last week. The downward spiral continued throughout the week, with the commodity shedding more than five percent in value. Increasing crude oil stockpiles, refinery turnarounds and increased oil production combined to push oil prices lower. Analysts say the declines could continue. Crude oil closed at \$97.85 Friday, down three percent on the week and the lowest close since July 1.

"Despite the recent pause in the decline, AAA continues to expect that gas prices will fall even further approaching the end of the year," said Jana L. Tidwell, public affairs specialist for AAA Mid-Atlantic. "Sufficient supplies,



flat demand and the shift to cheaper winter-blend gasoline, and barring a hurricane or other unexpected disruption to production and distribution, the national average is likely to fall to \$3.10 to \$3.20 per gallon by Christmas, which would be the lowest mark since February 2011."

Motorists are likely to see gas prices drop closer to the \$3.00 mark for the remainder of the year. Prices at the pump declined significantly in recent months, despite crude oil prices remaining above the \$100 threshold. However, now that crude oil prices are dropping analysts believe we could soon see gas prices drop to the lowest levels since the Arab spring in February 2011 when prices dropped to a national average of \$3.20 a gallon, AAA Mid-Atlantic reported



### **DuPont spinning off chemical unit**

he <u>DuPont board</u> has approved the spin off the company's Performance Chemicals segment, which including the Titanium Technologies and Chemicals & Fluoroproducts businesses.

DuPont operates a titanium plant in Edgemoor northeast of its headquarters in Wilmington.

The company has been under pressure from investors, including activist shareholder Nelson Peltz, who bought a stake in the company. The spin-off would leave DuPont with a faster growing group of businesses.

The sale of the business was not believed to be an option, according to some analysts who believed the value of Performance Chemicals already built into its stock price. DuPont shares were up nearly 2 percent at \$61.48. That is near a 13-year high.

"Following a thorough strategic review process over the last year, the spin-off of Performance Chemicals is clearly the best option to deliver enhanced value for our shareholders. This separation will advance the transformation of DuPont and result in two strong, highly competitive companies," said DuPont Chair and CEO Ellen Kullman. Since 2010, DuPont has made a number of acquisitions and divestitures, the biggest being Danisco, a leading food and bioscience business, while selling its Performance Coatings (auto finishes) segment earlier this year.

Delaware is losing jobs more than 300 jobs, due to the spin-off, now named Axalta, which is moving administrative jobs to Philadelphia and neighboring Delaware.

Kullman said DuPont expects to enable both companies to pay dividends that in total equal DuPont's dividend at the time of separation. The company anticipates fourth quarter separation costs of \$.01-.02 per share, which were not included in its third quarter 2013 earnings news release.

The Performance Chemicals segment had about \$7 billion in revenue in 2012.

# Global Start-Up Battle coming next month

Delaware will be part of the Global Start-Up Battle next month. The event will be held Nov. 15-17 in Wilmington. The event is part of <u>Startup Weekend</u>, a global grass roots movement of entrepreneurs who are learning the basics of founding startups and launching successful ventures. Startup Weekend held 400 events in 100 countries around the world.

The non-profit organization is headquartered in Seattle, but Startup Weekend organizers and facilitators can be found in over 200 cities from Mongolia to South Africa to London to Brazil.

All Startup Weekend events follow the same basic model: anyone is welcome to pitch their startup idea and receive feedback from their peers. Teams organically form around the top ideas (as determined by popular vote).

Next is 54 hours of business model creation, coding, designing, and market validation. The weekends culminate with presentations in front of local entrepreneurial leaders with another opportunity for critical feedback. Those wishing to participate can register here.



### Council again gets earful on Data Centers project

he Data Centers project made a return appearance at the Newark City Council meeting, Monday night.

The project been proposed for a portion of the University of Delaware Star Campus at the former Chrysler assembly plant. The final cost could total \$1.1 billion.

The site would include banks of computer servers with a natural gas-fired power plant providing what developers say is 100 percent "up time" for availability of massive amounts of data that need to be available online. About 20 percent of power generated could be sold on the PJM grid market.

Those speaking both for and against the plant have continued to use the public comments portion of the council meeting to air their views. A call to action to attend the meeting was issued on the No Newark Power

Plant website and the Delaware Way
blog, operated by Nancy Willing, who also spoke against the project.

The ferocity of the opposition has led some business and government leaders to worry that the state now has the reputation of being "closed for business" during a period of slow economic growth.

Some speakers defended Data Centers, based in West Chester, Pa. One called the Data Centers a "lifeline" for city residents who are likely to see higher taxes and fees in coming years. Harry Gravell, who heads the Delaware Building Trades Council and who serves as an officer in the state AFL-CIO, said the power plant would not be as large as critics suggest.

Later Ken Grant, who is leading an effort to promote the project as a source of jobs spoke in favor, citing the need to meet the future needs of an online world in need of constant access to everything from bank accounts to medical records. Grant has launched a <u>blog</u> on the project.

But backers were outnumbered by opponents like Amy Roe, who is running for mayor in a crowded field after the resignation of long time Mayor Vance Funk. Roe, a long time critic of the Newark electric utility, demanded a moratorium that would halt the project, which does not have any plans before the city.

It remains unclear as to how much say the city has over the project, given the fact that it is located at the site of a former auto assembly plant that is owned by the University of Delaware.

Council members have vowed to listen to the concerns of residents, but weariness over the controversy was apparent. Council members listened patiently to the complaints, with many speakers coming from the Third Council District, which is near the proposed site of the center. The council and city staff have been under

fire for what critics claim was a lack of transparency about the project, which was first reported last spring by the Business Bulletin.

Opposition did not pop up until summer as word of the project spread and a controversy cropped up regarding a Wawa on Elkton Road. Funk said the controversy over the Wawa project contributed to his decision to retire as opponents wore plackards, put up yard signs and left stinging e-mails regarding the proposed convenience store proposal near his home. Funk has since moved to Main Street.

One resident said those living near the proposed data center were feeling "beat up," by out of town union members and business interests talking up the project and others who claim residents do not care about jobs.

Two speakers said Newark is in relatively good economic shape and did not need the construction and operating jobs. At least two speakers questioned the presence of yard signs outside the Newark Municipal Building in support of the project, Others claimed property values would drop.

At times, resentment bubbled up against the university, with one speaker tearing what he said was a contribution request.

Rarely was the term data center used by speakers who focused on the power plant portion of the project, describing it in terms usually reserved for coal or nuclear plants.

One speaker went so far as to bring a device with recorded sounds to the speaker's podium that he claimed represented the noise level that would come from the power plant.

In one detailed presentation, a speaker claimed wages paid by non executives would be a little over \$40,000 a year, a figure that would do little to aid the economy.

Others described Newark as a residential community that no longer needs industry and would be better off attracting residents with its high-quality lifestyle.

State labor market data shows Newark has the lowest jobless rate of any city or county in the state, although the jobless rate is up from historical lows.



In 1916, Beebe was a two-room hospital. It became a medical center as it grew and offered more medical services. Today, the name Beebe Healthcare signifies a community health system that provides sophisticated medical care across many locations."

### Treasurer defends trip, seeks retraction

Flowers continues to demand a retraction from the News Journal over articles about his trip to Alaska for the National Association of State Treasurers conference.



A lengthy story on Sunday took a look at the trip, where he was accompanied by a former deputy state treasurer who went on leave, after earlier reports on improper use of a state credit card.

In the most recent <u>story on Tuesday</u>, Facebook photos of a side trip in the scenic state were published by the newspaper.

"The News Journal clearly has no evidence that the state credit card was used improperly on any private trip in Alaska taken by the Treasurer or former Deputy State Treasurer during off-time (such private activities are permitted under state law)," Flowers stated. "Since no taxpayer funds were used by the former Deputy State Treasurer's during her time-off or the Treasurer's limited free time (visiting a historic national state park), the implication by the News Journal that the statements provided by the Treasury

are false is a poor attempt to distract readers from the required retraction relating to Sunday's article, as the News Journal was incorrect and remains incorrect in reporting that the Treasurer's trip was funded by taxpayers (taxpayers were not charged \$5,000). This is blatantly false."

Spending for trips been an area of controversy in the state, with former Gov. Ruth Ann Minner taking a trip to Canada via private jet that was paid for by Chris Tigani, the News Journal reported. Tigani later convicted of campaign finance violations.

Such stories, normally stay in Delaware, but this week ended up on Philadelphia television, with Flowers defending his actions on camera on NBC 10.

Flowers says he has helped add \$30 million to the state investment portfolio, but has come under fire the administration of Gov. Jack Markell and state investment advisors. Markell is a former State Treasurer. Flowers' office, which has been renamed the Delaware State Treasury, also issues a monthly economic status report for the state.

# LTE wireless speeds lag in the the area

The report from the Quartz business website blamed the lack of a developed network by Sprint as the reason for the low speed. Verizon has the highest speed. Sprint is working to build out its LTE network.

Other carriers are doing the same as more people buy wireless devices and phones capable of using the technology.

LTE speeds approach those of wired systems in offices.

Northern Delaware was not mentioned in the report, although its wireless networks generally mirror the performance of those in nearby Philadelphia.

Wireless network performance is becoming an economic development issue as more people do work in remote locations.



### Police log: Contractor gets 6 months; 3 Islamic center arrests

**Information** given to the Delaware State Police and the FBI regarding vandalism at the Islamic Society of Delaware, 28 Salem Church Road, led to charges against three juveniles. A State Police spokesman said the incident did not appear to be a hate crime. Salem Church Road is located outside of Newark.

On Tuesday, troopers reported that two residents came forward with information about juveniles. Troopers and FBI agents took three 16-year-old Newark males into custody.

"After a thorough and comprehensive investigation by the Delaware State Police and the FBI, there was no conclusive evidence to show that this act of vandalism was directed, targeted, or focused towards the Islamic Society of Delaware because of its religious affiliation or intended to intimidate the Islamic community" said Sergeant Paul G. Shavack, director of Public Information for the Delaware State Police. "We have determined that it was a

random act of vandalism, and have no evidence at this time to support classification as a hate crime."

Troopers charged each with one count of criminal mischief over \$5,000, and conspiracy second degree. One defendant was released on \$4,000 unsecured bond. And other defendant was released on \$2,000 unsecured bond, and the third defendant was committed on \$2,000 secured bond to a juvenile facility.

#### **Contractor sentenced**

Jeffrey Justison, 44, of Elkton was sentenced Tuesday in Delaware by United States District Court Judge Richard G. Andrews to six months jail time. followed by six months house arrest, for failure to collect, and pay federal income taxes from his employees.

Based on statements made at the sentencing hearing and documents filed in court, Justison owns Double J Concrete, Inc., which he operates from his Elkton home. From June 2007 through December 2010, Justison performed concrete jobs in Delaware and surrounding states, with approximately 20 workers. Justison paid his employees in cash, failing to collect from them, and to pay over to the

IRS, Federal Income Tax and Federal Insurance Contribution Act (FICA) taxes. He also failed to pay his matching employer's portion of FICA taxes, resulting in a total of \$184,829 in unpaid taxes.

"IRS Criminal Investigation realizes the detrimental consequences of employment tax evasion. It results in the loss of tax revenue to the United States government and the loss of future social security or Medicare benefits for the employees," stated Akeia Conner IRS special agent in charge.
