

## **Incyte top-performing stock** in ranking of state companies

**ilmington-based** Incyte Corp. has topped a list of top performing publicly traded companies.


The list from SmartAsset looked at stock performance on a state by state basis. (Click on graphic for larger image).

"We wanted to find the companies with stock prices that have grown the fastest and paid the most in dividends while providing the least amount of risk to investors," a release announcing the list stated.

SmartAsset calculated at the stock price, dividends and volatility of each company over a time period of a little more than five years, ending

March 15. "Finally, we indexed and ranked each of the companies based on this risk-adjusted return to find the best performing stocks across the country and by state," the release stated. Incyte topped the list in annual return and risk-adjusted ratings. The pharmaceutical company, based near Wilmington, developed the drug Jakafi, which is used to treat blood cancers. It is also focusing on other drugs that can treat cancer and other diseases.

Incyte now has a stock market value of \$22.6 billion. Coming in second in the overall rankings was Chesapeake Utilities, Dover. Chesapeake has been growing in recent years as natural gas supplies increase. Lower and less volatile natural gas prices have allowed the company to expand its customer base in Delmarva and a small portion of Florida. The company has also made natural gas well gathering and utility acquisitions in recent years.

Chesapeake's dividends and reliable earnings stream allowed it to edge out banking and financial services company WSFS for the number two spot. WSFS ranked No. 3 overall. Its stock had a higher annual rate of return than Chesapeake.

No. 4 was DuPont Co., which won a bruising proxy fight earlier this year with investor Nelson Peltz. Peltz has taken credit for the surge in DuPont's stock price. DuPont has been selling or spinning off slower-growing operations. In July it spun off various chemical businesses into Chemours, which quickly moved to close the Edgemor titanium dioxide plant near Wilmington Companies on the list had a stock market value of \$50 million or more. That left Dover Downs Gaming and Entertainment off the list.

The one--casino company has struggled to get its stock price above \$1 a share, the minimum required for a New York Stock Exchange Listing. Late last week, Dover Downs shares were trading slightly above \$1, with a total stock market value of \$35 million.

## **Delmarva Poultry trade group taking** on chicken house moratorium backers

Delmarva Poultry Industry is criticizing calls for a moratorium on construction of chicken houses.

Environmental groups, mainly in Maryland, have suggested the action, citing the need to reduce



phosphorous levels in Chesapeake Bay. The most publicized effort has come from the Environmental Integrity Project, which published a study criticizing the lack of regulation by the state of Maryland.

In Delaware, the Environmental Protection Agency issued a report indicating the state Department

of Agriculture needed to do a better job of dealing with a permit backlog involving farms in the Chesapeake Bay watershed, which includes a sizable portion of the state.

"As with any industry, updated and modern facilities are required to keep businesses competitive, including farm family-owned chicken farms. The new chicken houses include the latest technology and have landscape designs and environmental protection systems that exceed existing chicken housing. Water quality improvements are likely to be enhanced with the new chicken houses and their stormwater management plans," DPI stated. The trade group is based in Georgetown, DE.

The statement went on to criticize other findings of the study, including the claim that chicken meat production will rise by 2 percent a year. DPI said the figure is lower.

At the same time, the number of chicken houses actually declined by 25 percent between 195 and 2014 and capacity went down by about 3 percent,

DPI stated. DPI did note that with the economic recovery, more new structures are being constructed. Farmers and the industry are also working to reduce phosphorous, the trade group noted.

In Delaware, the new structures contributed to a record level of Small Business Administration lending in 2015. The SBA loans are in addition to other federally backed financing options for growers.

There have been concerns regarding <u>clusters of chicken houses</u> that can bring complaints of odors and other problems.


Complicating the situation is continued population growth in portions of the peninsula, sometimes in locations that are near chicken houses.

"Opponents of the chicken industry who favor the moratorium on chicken house construction until full implementation of the Phosphorus Management Tool regulation in 2024 are hoping that by killing construction they will kill the chicken industry," DPI stated.

Last year, DPI held its last Chicken Festival on the peninsula, citing the need to focus on issues facing the industry.

Issues in Delaware, while not handled by DPI, have included the purchase of a former Vlasic pickle factory by processor Allen Harim. Opponents have cited concerns about water pollution if the site becomes a processing plant.

The company has proposed a plan to clean up pollution at the site, with supporters claiming doing nothing about the existing pollution is worse than coming up with a clean-up plan.



# Governor aims to boost trade ties with trip to Germany

ov. Jack Markell is in Germany in an effort to strengthen business relationships that now include a manufacturer operating a small plant in Dover.

The meetings, with business representatives from Bavaria and others in Germany, come on the eve of Munich's world-renowned Oktoberfest.

The visit follows this year's launch of the Department of State's 'Global Delaware' initiative and focuses on the three goals of the program: paving the way for Delaware companies to increase exports, building on Delaware's global leadership in corporate governance and as a preferred site of incorporation, and promoting the state as a place for foreign companies to expand, a release satted.

"Success for our state in the 21st century means looking beyond our borders for ways to create jobs and economic opportunity for Delawareans," said Markell. "In a world where businesses have more choices than ever about where to invest and where Delaware companies have more opportunities than ever to sell their products around the globe, we must ensure that leading international business communities appreciate all that Delaware has to offer."

The primary goal of the mission is to strengthen ties with the prospering smalland mediumsized companies (known as "Mittelstand") of Bavaria, and its capital city of Munich, by meeting with individual businesses as well as organizations that represent and support

them. The Mittelstand gave been credited with allowing Germany to have the strongest economy in Europe.

Delaware aims to leverage its recently strengthened relationship with German companies, including the research company Fraunhofer and the manufacturer Uzin Utz, which will soon open its first U.S. plant in Dover.

In addition, Glasgow is the home of a medical diagnostics operation for German industrial giant Siemens.

"As a German company that has found Delaware to be a great place to do business, we are excited that the governor is making this trip not only to our home country, but specifically to build relationships in the South of Germany," said Philipp Utz, president of Uzin Utz Manufacturing North America Inc., a manufacturer of specialty flooring installation products. "Delaware has a lot to be proud of, with a growing business community, a state-of-theart infrastructure and the ability to offer a skilled workforce. It will be of great benefit to many other German entrepreneurs to learn about the state and Delaware companies will also have a lot to gain from better ties with Germany's economy."

As part of Markell's new export initiative, he will work to develop a network of trade partners for Delaware companies to build on recent success. Germany was one of four key international markets identified as part of the initiative, which focuses on countries with the most buying potential for the products and services that Delaware has to offer.

Delaware exports to Germany have grown by 28.8 percent in the last two years. In 2014, Delaware exported \$390.4 million in goods and services to Germany. The German economy is the world's fourth largest, accounting for more than one-fifth of the European Union's GDP, and Germany is the United States' largest European trading partner, as well as the sixth-largest market for U.S. exports.

Finally, Markell will discuss opportunities to increase foreign direct investment (FDI) by Germany in Delaware. Germany invests more than \$270 billion per year in the U.S.

Germany is the fourth largest investor in Delaware, pouring in more than \$270 million per year as of 2013. The state delegation arrives in Munich on Tuesday and returns the following Monday,

The trip is estimated to cost less than \$50,000 and will be the first foreign trade mission in which the governor is participating since he visited Israel two years ago.

The launch of Global Delaware provides an opportunity to expand on progress from the Governor's earlier international efforts and has already produced results.




I would like to share the things I really like about Win 10.

Notifications: The notification center on the lower, right-hand side of the screen acts as a shortcut to the settings that I change most frequently on the computer, such as turning on silent mode, toggling Bluetooth on/off, and connecting to VPN. The notification center replaces the charms menu on Windows 8. It is intuitive and I feel in control.

File Explorer: By a close second, I like the

best of the Windows 7 start menu in a familiar File Explorer context.

**Program preview:** There is a big improvement in the program preview feature, which I access with the keyboard shortcut Windows + Tab keys.

This brings up a full screen of the programs running with large previews to accurately select the window you want. Care and thought were put into window placement controls.

Depress the Windows key while pressing the left or right arrow key to swiftly move the active window to precisely fill the left or right half of your screen. (I prefer more efficient keyboard shortcuts to the mouse to speed up the work process.)

Releasing the Windows key results in a visual prompt to choose which program to snap to the other half of the screen.

This quickly permits side-by-side document viewing and makes the most of real estate on larger monitors. Swift start-up, shut-down: Windows 10 starts up and shuts down faster than Windows 7 and it seems to come out of sleep mode more reliably than Windows 8.

One important note: I never do high-stakes upgrades on any computer that is integral to doing my job, and neither should you.

For your business computers, rely on your managed service provider or IT department to make planned upgrades or risk being isolated on the island of broken customizations.

On a modern PC, i.e., less than two years old, the full upgrade takes less than an hour and, in my opinion, is flawless. I've updated 10 PCs without the slightest hitch. The upgrade from either Windows 7 or 8/8.1 is absolutely free.

## Budget, spending report generates a predictable response


As noted last week in an analysis of the Business Roundtable report on structural problems with the state budget, the findings would get a chilly reception in some corners of Legislative Hall.

Indeed, Pete Schwartzkopf and Patricia Blevins, House Speaker and Senate Pro Tem respectively

took the time to pen a *News Journal* <u>opinion piece</u> that proved to be a defense of the status quo.

In short, the guest column from the Democratic legislative leaders recited the usual spiel about the state's vaunted financial strength and efficiency.

They made a couple of good points about spending cuts alone not solving problems, an approach championed (often without specifics) by Republican legislative leaders who also need to look at fresh approaches.



One big reason is the fact that the highly cyclical auto industry no longer exists in this state. Other long-time manufacturing employers are also shutting down, with those out of work often seeing sharp cuts in pay in a job is available.

Other large private employers have trimmed layers of middle managers that also added to the tax base.

On the spending side, categories, such as education and corrections, run well above the national average.

Education has gotten a pass from the corporate sector due to efforts to improve student performance, but many suspect a sizable percentage of our high per pupil cost is not making its way into the classroom. Corrections also remains a sacred cow in need of a thorough review. Medicaid costs are another issue that could use a fresh look.

Without decisive actions, the budget gap could eventually swell to \$600 million.

The lack of a recovery in revenues is not unique to the region, but Delaware has typically enjoyed a more vibrant economy, thanks to a friendlier business climate, lower taxes and fewer units of government than neighboring New Jersey and Pennsylvania.

The Roundtable report pointed to a study of the revenue structure that offered reason for hope. Sadly, the legislative leaders made no mention of the study, casting doubt on whether its findings will end up in a forgotten digital archive.

The column from the House and Senate leaders did make some vague references to a "holistic" look at the budget that would presumably include tax and revenue increases and spending cuts. Left un-**Continued on next page**

answered are questions about whether taxpayers are getting their money's worth, a point noted last week in looking at Republican State Treasurer Ken Simpler's approach.

As long as these concerns remained unanswered talk of tax and revenue increases to address the budget gap is premature.

Moving toward Simpler's approach would not be difficult in this era of big data that can quickly crunch numbers and analyze complex streams of information.

Finally, it is fair to ask whether the current legislative system is capable of dealing with such weighty issues. Perhaps the cronyism and favors to insiders that have been noted in a campaign finance report by former Supreme Court Chief Jusice Norman Veasey have caused irreparable damage.

The Roundtable report has less than 30 pages and provides few answers. However, it deserves to be taken seriously by those in high places.

The SBA manages STEP nationally; however, activities are managed and provided at the local level by state government organizations.

Recently, SBA announced the FY 2015 STEP Awards, providing \$17.4 million to promote small business exporting. STEP will unlock capital for small businesses to help them enter and compete in the global marketplace.

In 2014, U.S. businesses exported \$2.35 trillion of goods and services, hitting a record high for the fifth straight year. In that same year, U.S. exports increased 2.7 percent to a record \$1.64 trillion. Exporting provides tremendous opportunities for America's small businesses that are looking to expand and grow. Recipients in the first two rounds of STEP awards, in FY 2011 and FY 2012, reported a strong return on investment of over 19:1.

In 2013, Delaware's ANP Technologies visited Israel as part of the STEPfunded Delaware State Delegation.

On that trip, ANP met with a large number of potential partners, among them, the Israeli company Merkot. ANP credits that STEP-funded opportunity with its ensuing partnership with Merkot and, together, their being awarded a Binational Industrial Research and Development (BIRD) Foundation grant to develop an automated monitoring system to detect pesticides in water. For ANP, it is clear that its participation in SBA's STEP program allowed it to establish international commercial ties for its small business.

# Claymont office building headed to auction block



An office building in Claymont is headed for an auction at the end of this month.

CBRE and Auction.com will put the building up for auction on Sept. 30.

Built in 2001, the property is located directly at the intersection of Interstate 95 and Interstate 495 near the state line with Pennsylvania.

The building is part of a three-building complex

that includes one additional office building and the 191 room Crowne Plaza Hotel.

The building is about 12 miles from the Philadelphia International Airport and nine miles from downtown Wilmington.

The property is also a short distance from former Evraz Claymont Steel mill. That site is slated for a major redevelopment project at a site that has rail, highway and river access. Some redevelopment has also taken place in Claymont itself.

The property will start with a minimum bid of \$750,000.

The building is designed to accommodate a parking ratio of 4.8 per 1,000 square feet, a drawing card for a potential owner, since more employees are being packed into less space at office complexes.

#### **Pettinaro marks 50th anniversary**

Projects include Hodgson VoTech School, Smyrna Prison, Flat Rock Dam in Pennsylvania, Chadds Ford Ramada Inn, U.S. Postal Distribution Center, University of Delaware Morris Library, Cecil County Maryland Prison, New Castle Middle School, Ferris School for Boys, and Wilmington Amtrak Station renovations.

In the '80s and '90s, Pettinaro bought developments in need of renovation including Greenville Place Apartments (Monroe Park), Paladin Club Condominiums, Krebs's School, Chase Center Exhibition Center, and areas of the Wilmington Riverfront.

Verino's son, Gregory, took over the management of the company in 2005. In 2015, this second generation family-owned company is celebrating its 50th anniversary.

"We are very proud of my father, Verino. He lived the American dream of how hard work can bring you success. We continue today in his 'never give up' attitude," says Gregory Pettinaro.

#### **Allan Myers buys Daisy Construction**, **Edgemoor Materials assets**




and quality craftsmanship, enabling them to fit well into the Allan Myers culture and continue our drive for excellence."

Other major themes included providing support for the whole child-including social and emotional support; encouraging collaboration across sectors, grade levels, and between families and schools; and elevating the value of the teaching profession in the community.

## Deal to boost Delaware bank's presence in southestern Pennsylvania WSFS-Alliance Bancorp merger clears final hurdle

SFS Financial Corporation moved a step closer to completing the acquisition of a suburban Philadelphia bank.

The Wilmington-based financial services company announced the Office of the Comptroller of the Currency approved <u>WSFS Bank's</u> application to merge with Alliance Bank, the wholly owned subsidiary of Alliance Bancorp, Inc. of Pennsylvania.

The OCC's approval was the final regulatory approval required for WSFS to acquire Alliance Bancorp and Alliance Bank.

"We are very pleased to have received the OCC's approval, which was the final regulatory approval to completing the transaction," said Mark A. Turner CEO of WSFS Bank. "Our partnership with Alliance Bank furthers many of our strategic goals including expanding our service-oriented, community banking model deeper into Southeastern

Pennsylvania. WSFS and Alliance Bank share many of the same values,

of the values.

including the passion for serving our customers and a steadfast commitment to local, community banking."

The approval from the OCC follows okays from Alliance Bancorp shareholders and the Pennsylvania Department of Banking and Securities. The acquisition is expected to add to WSFS earnings per share in the first year of combined operations, excluding transaction and integration costs.

The acquisition is expected to be completed on October 9 and the systems conversion of Alliance Bank to WSFS Bank's systems is expected to occur by October 13.

WSFS bank We Stand For Service"

Following the transaction, WSFS Bank will have 63 offices including 17 locations in southeastern Pennsylvania and will have \$5.5 billion in assets. WSFS is the oldest and largest bank based in the Delaware Valley.

Over the years, Philadelphia-area banks have been acquired by holding companies based in Pittsburgh, Charlotte and other cities. In Delaware, Wilmington Trust, one of the largest banks in the region, was acquired by M&T after problems with loans and management practices.

A number of former Wilmington Trust and officials at smaller Delaware banks have faced or are facing federal charges.

WSFS earlier completed a merger with First National Bank of Wyoming, a financial institution based in Kent County, DE.

The R&D center would replace an existing site in Delaware and appears to mean that the company will not have a presence in the state after being sold by DuPont to an investment group a couple of years ago.

Axalta also announced plans to build a customer experience center in North Carolina. The company has maintained close ties with North Carolinabased Hendrick Motorsports which sponsors a major NASCAR racing team.

Retiring Hendrick driver Jeff Gordon had a long relationship with DuPont and later Axalta.

Axalta is now publicly traded, with Omaha investor Warren Buffet's Berkshire Hathaway holding a large stake in the maker of automotive



finishes for auto, truck and other industries.

Axalta has its headquarters in Philadelphia and North American administrative operations in Concord Township near the Delaware line. The two offices have a combined workforce of 300, many of whom had been based in Delaware while the operation was owned by DuPont.

Axalta was in the news during this year's proxy battle with DuPont management and Trian Partners. Trian, led by billionaire Nelson Peltz, claimed DuPont sold Axalta at a bargain basement price.

## State holds on to top legal climate ranking for 10th straight year

Delaware has now held on to the top corporate legal climate ranking for a decade.

A new survey by the U.S. Chamber of Commerce ranked Delaware first for the fairness and reasonableness of the state's legal system, rating the state number one for the tenth consecutive time since the periodic surveys began in 2002.

This year's findings, based on interviews with a national sample of more than 1,200 in-house general counsel and other executives who are knowledgeable about business litigation, put Delaware in the top two in all ten of the report's categories, including first place in overall treatment of tort and contract litigation and judges' competence.

The ranking comes as some corporate chiefs complain the state is no longer as business friendly on the legal front. A recent Chancery Court decision went against top officials of Dole on claims that the company was undervalued in a buyout. That led to litigation and a nearly \$150 million ruling on behalf of shareholders.



"This report reflects a relentless commitment to predictability and fairness in our laws and our judiciary, and it confirms that Delaware's standing as a premier place to do business remains as strong as ever," said Gov. Jack Markell. "But, most of all, the number one ranking recognizes the talented jurists across all of our courts who consistently demonstrate outstanding intellect and legal expertise that produce thoughtful decisions."

The administration went on to note that the rnaking is another factor in a favorable business climate in the state.

"Recovering from the recent recession, the state set an all-time high for number of jobs and Delaware's job growth continues to lead the region, while the unemployment rate continues to be below the national figure. Led by private employers, the state has seen 38,000 jobs created since the depths of the recession and has been recognized as one of the states best-prepared for the new economy," a release stated.

The release also noted that the state set historic highs in the number of new companies formed, the percentage of Fortune 500 companies incorporated in the state, and the percentage of US initial public offerings (IPOs) from Delaware companies.




