Delaware earns top ranking in broadband speed report

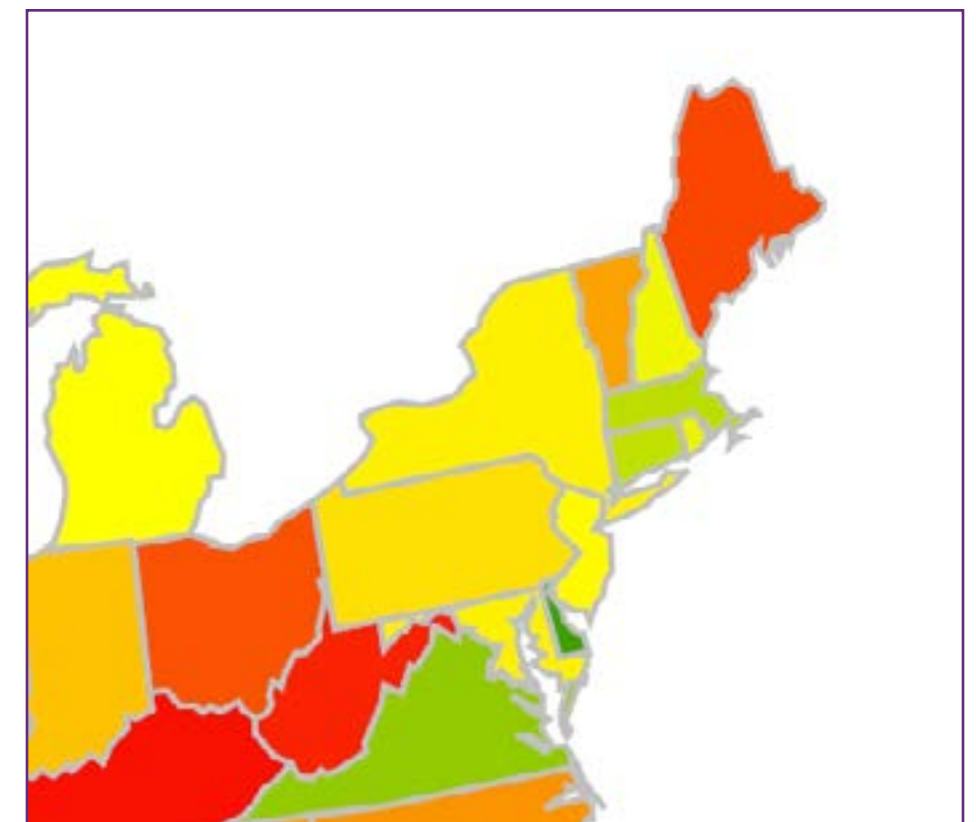
A report from an online monitoring firm has Delaware ranking at or near the top when it comes to the speed of broadband Internet connections. The report comes from [Akamai](#), a cloud computing services and content delivery network based in Massachusetts.

Higher broadband speeds are essential in delivering cloud-based services that allow companies to store and distribute data via remote servers at data centers.

Delaware is the top state for all five measured categories including: average and peak connection

speeds, broadband and high broadband connectivity and 4K readiness. 4K streams generally require between 10 - 20 megabits per second of bandwidth. The ranking provides an insight into the states most likely to be able to sustain such high-speed streams that could be used for video and other types of transmissions.

On a year-over-year basis, all of the states in the top 10 saw significantly higher average connection speeds as compared to the second quarter of 2013, Akamai reported. New Hampshire had the smallest yearly increase across the group, at 20 percent, while Delaware's 50 percent jump was the largest. Across

the whole country, only Kansas saw its average connection speed more than double over the last year, up 106 percent (to 3.4 Mbps). Every state saw more than 10 percent growth on a yearly basis.

The report dealt with numerous issues worldwide including distributed denial of service attacks. This occurs when multiple requests flood a site and cause it to slow down or not function.

Akamai customers reported 270 attacks in the second quarter, down from 283 in the first quarter, marking the second consecutive quarter with a decline and a drop of 15 percent year over year. Although the number of such attacks

worldwide is down, the Americas showed an 11 percent increase in the number of attacks, claiming 57 percent of all reported attacks. Meanwhile, Asia Pacific has experienced the largest decline in reported DDoS attacks quarter over quarter, dropping 23 percent from the first quarter to the second quarter.

Europe, Middle East and Africa remained in third place with a modest decline of 14 percent, amounting to 18 percent of all reported DDoS attacks. In the second quarter, attacks against the high tech sector continued an upward trend with a 60 percent increase.



Delaware Art museum retires debt with sale of paintings

The Board of Trustees of the [Delaware Art Museum](#) announced that the museum's \$19.8 million bond debt, issued in 2003 to finance an ill-timed expansion, was paid in full on September 30.

After years of attempting to retire the debt through fund-raising, refinancing, and partnerships, the museum's trustees voted unanimously in March to sell up to four works of art from its 12,500-object collection.

The bond debt will be paid with proceeds from the sale of William Holman Hunt's *Isabella and the Pot of Basil* (1868), the recent private sale of Alexander Calder's *Black Crescent* (1959), and funds from the museum's investment portfolio. Proceeds from the sale of Winslow Homer's *Milking Time* (1875) and a possible fourth work are expected to replenish the investment portfolio when the sales are completed. No works of art acquired through gifts will be sold.


"Payment of this debt is a critical milestone in the history of the Delaware Art Museum," says Delaware Art Museum CEO Mike Miller. "This process has been excruciatingly difficult for everyone involved. Thankfully, we have been

bolstered and supported by our loyal members and donors. We are so appreciative of the overwhelming support from our community."

The museum has paid a high price for the sales. It lost accreditation and dealt with widespread criticism in museum circles. However, others in the community have said the museum had no choice. The museum operated without a director during the sale process.

Miller previously stated the museum might have to close if the debt burden was not addressed.

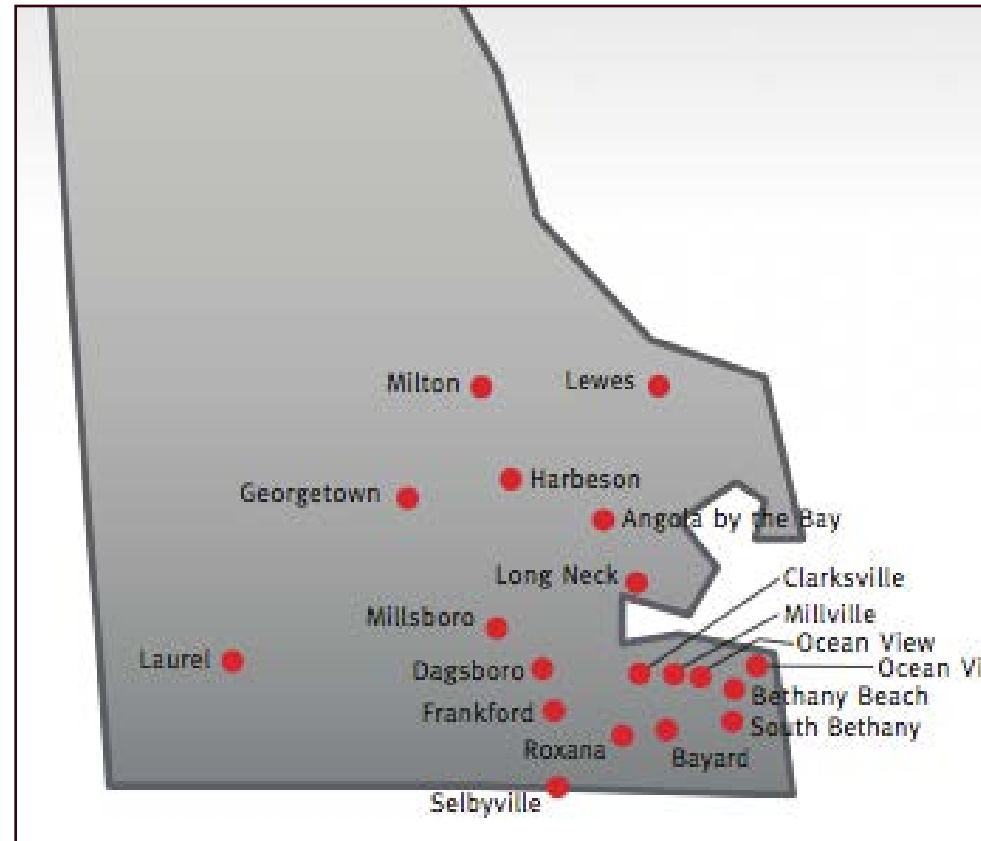
Federal rural broadband program plays role **Mediacom rolling out fiber for schools, business**

Mediacom Business announced it is ready to partner with schools and libraries in its service areas in a recently announced federal program to subsidize broadband and Wi-Fi for schools and libraries with their Gigabit+ Fiber Solutions. Service.

The Gigabit+ Fiber Solutions.service is also available for businesses in its service area in Delaware.

Mediacom provides cable TV and broadband service in portions of Sussex County as well as Delaware City in New Castle County. Delaware was recently ranked as having the fastest broadband access among the 50 states. (See story on page 1).

Dan Templin, senior vice president of [Mediacom Business](#), said the Federal Communications Commission has approved a plan to phase out funding under a program known as E-rate for antiquated technologies like pagers and dial-up phone service, redirecting \$2 billion to boost



wireless Internet connectivity in U.S. schools and libraries over the next two years.

Templin said his company has local representatives available to advise and consult about implementing Gigabit+ Fiber Solution in conjunction with the FCC announcement. “Approximately 1,000 schools in the communities we serve have access to the Internet over our high-

capacity fiber network. We have a unique ability to scale broadband to the exact requirements of each individual school, and the expertise to manage and monitor these services around the clock.”

It should be a priority for every business and city – it’s just as critical as providing water and electricity and it will be what drives economic development,” said Kristi Salmon of Mediacom. “With Gigabit+ services via fiber, we are talking about big data that needs this kind of throughput and community anchor institutions that need connectivity for multiple locations so everyone can access that data simultaneously in real time – wherever they are. This is a huge leap for rural America and Mediacom Business is providing the type of service that traditionally was only available in larger metro areas.”

Mediacom is the nation’s eighth-largest cable provider and the largest serving rural areas, according to company statements.



Frontier to resume flights to Philadelphia

Carrier pursues big city strategy

In what could be an ominous development for [New Castle Airport](#), (ILG), [Frontier Airlines](#) is expected to return to Philadelphia.

The airline announced nonstop flights from Philadelphia International Airport to Miami, Orlando, and Tampa, Fla., and Cancun, Mexico, in December. Atlanta, Charlotte, N.C., and Chicago will be added in the spring.

Frontier also announced a one-day sale on Tuesday with fares as low as \$15 one way from Philadelphia.

Frontier will offer flights from New Castle to Tampa and Orlando this winter and has not ruled out resuming additional service from New Castle this summer.

Frontier is dropping service to Chicago, Denver, Fort Meyers and Atlanta in the fall from New Castle.

Frontier is now owned by Indigo Partners and

with a beefed up management team in place is not afraid to add flights in larger airports. Frontier had previously dropped Philadelphia from its flight schedule. Indigo previously owned a controlling interest in Spirit Airlines, which also flies out of Philadelphia.

The carrier now sees opportunities in major markets, due to airline mergers, including the combination of US Airways and American Airlines.

Until Indigo took over, the airline had tended to look at airports with lower landing fees. It is now

testing whether it can compete head-to-head with Spirit in Cleveland, Ohio.

There will be no overlapping non-stop flights out of Philadelphia between Frontier and Spirit. Spirit offers non-stops from Philadelphia to Dallas, Las Vegas and on a seasonal basis, Myrtle Beach. Like Spirit, Frontier operates with the ultra-low fare model that includes charges for all luggage.

Frontier recently added service at Chicago O'Hare, one of the nation's two busiest airports to its system, while beefing up its flight schedule in Cleveland, a city that has seen a reduction in flights from bigger carriers.

Critics have claimed that air fares from Philadelphia have crept up since the merger, although the two carriers still operate separately.

Frontier told Philly.com it has no plans to slash service from Trenton/Mercer County. The airline has beefed up flights from the airport, which also serves a large swatch of New Jersey. Much of the market for the New Castle Airport is within a 30 to 45-minute drive of Philadelphia. Frontier launched

'Hackers' accused of stealing \$100 mil. in intellectual property

Targets include Xbox game system, Army technology

Four members of an international computer hacking ring have been charged with breaking into computer networks of technology companies and the U.S. Army and stealing more than \$100 million in intellectual property and other proprietary data.

The charges were announced on Tuesday, with prosecutors releasing various items including audio

and this screen capture of a hacking session. Two of the charged members have already pleaded guilty. The alleged cyber theft included software and data related to the Xbox One gaming console and Xbox Live online gaming system; popular games such as "Call of Duty: Modern Warfare 3" and "Gears of War 3"; and proprietary software used to train military helicopter pilots.

U.S. Attorney Charles M. Oberly III of the District of Delaware, Assistant Attorney General Leslie R. Caldwell of the Justice Department's Criminal Division, and Special Agent in Charge

Stephen E. Vogt of the FBI's Baltimore Field Office made the announcement.

"Electronic breaking and entering of computer networks and the digital looting of identities and intellectual property have become much too common," said Oberly. "These are not harmless crimes, and those who commit them should not believe they are safely beyond our reach."

The indictments touch on a shadowy area of the tech world that believes companies keep prices too high and justifies hacking as a way to reduce those costs. Hackers also look for buyers of the code that can then be illegally distributed.

Nathan Leroux, 20, of Bowie, Md; Sanadodeh Nesheiwat, 28, of Washington, N.J.; David Pokora, 22, of Mississauga, Ontario, Canada; and Austin Alcalá, 18, of McCordsville, Ind., were charged in an 18-count superseding indictment returned by a federal grand jury in the District of Delaware on April 23, 2014, and unsealed on charges in the indictment include conspiracies to commit computer fraud, copyright infringement, wire fraud, mail fraud, identity theft and theft of trade secrets. The defendants are also charged

service from New Castle in July 2013 and saw flights running at 90 percent occupancy. At the time, Frontier executives cited the hassles of flying out of Philadelphia, which has a limited number of runways and is prone to flight delays. By contrast, the New Castle Airport has been praised for its level of service and features such as free parking. By contrast, travelers can pay as much as \$20 a day for parking near the terminal in Philadelphia. News of service cuts from New Castle has angered travelers

who said the full flights showed the popularity of the service.

However, aviation analysts cautioned that airlines will seek markets where fares have soared and profits are potentially greater.

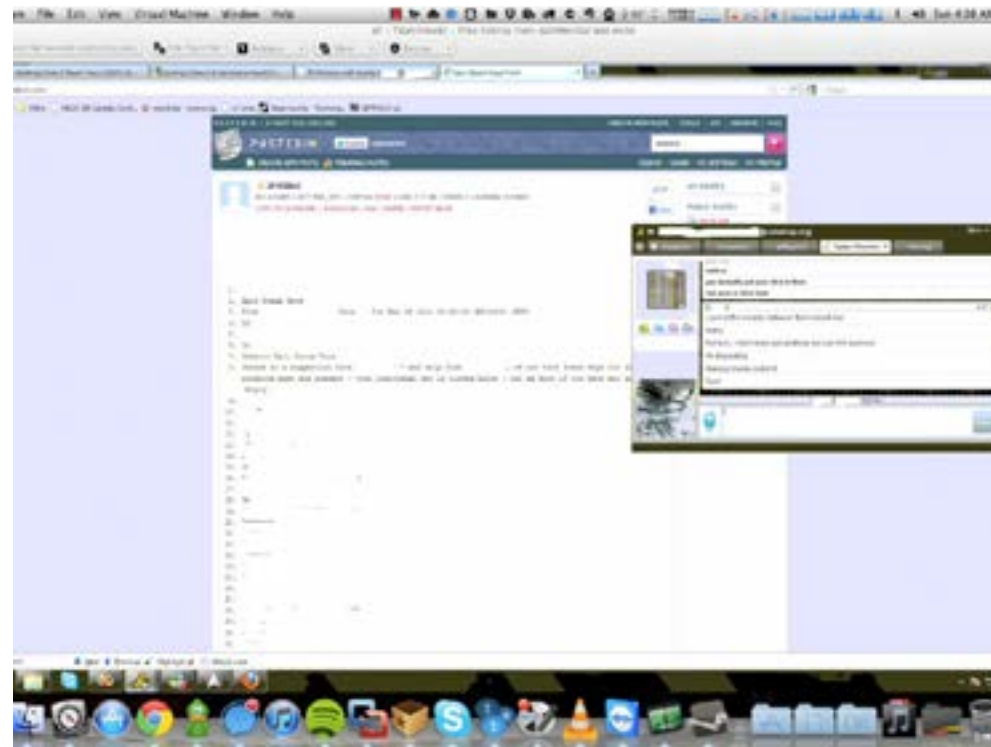
Prosecutors claim hackers tapped into code on Army copter

with individual counts of aggravated identity theft, unauthorized computer access, copyright infringement and wire fraud.

On Tuesday, Pokora and Nesheiwat pleaded guilty to conspiracy to commit computer fraud and copyright infringement. Sentencings have yet to be scheduled. Pokora was arrested on March 28, while attempting to enter the United States at the Lewiston, N.Y. Port of Entry. Pokora's plea is believed to be the first conviction of a foreign-based individual for hacking into U.S. businesses to steal trade secret information.

According to the superseding indictment and other court records, from January 2011 to March 2014, the four men and others located in the United States and abroad allegedly hacked into the computer networks of Microsoft Corporation, Epic Games Inc., Valve Corporation, Zombie Studios and the U.S. Army. The defendants and others allegedly obtained access to the victims' computer networks through methods including SQL injection and the use of stolen user names and passwords of company employees and their software development partners.



Once inside the victims' computer networks, the conspirators accessed and stole unreleased software, software source code, trade secrets, copyrighted and pre-release works and other confidential and proprietary information. Members of the conspiracy also allegedly stole financial and other sensitive information relating to the companies – but not their customers – and certain employees of such companies.

The data cyber-theft allegedly included source code, technical specifications and related information for Microsoft's then-unreleased Xbox One gaming console; intellectual property

and proprietary data related to Xbox Live, Microsoft's online multi-player gaming and media-delivery system; Apache helicopter simulator software developed by Zombie Studios for the U.S. Army; a pre-release version of Epic's video game, "Gears of War 3;" and a pre-release version of Activision's video game, "Call of Duty: Modern Warfare 3." The defendants also allegedly conspired to use, share and sell the stolen information.

The value of the intellectual property and other data that the defendants stole, as well as the costs associated with the victims' responses to the conduct, is estimated to range between \$100 million and \$200 million. To date, the United States has seized over \$620,000 in cash and other proceeds related to the charged conduct.

In addition to those charged in the United States, an Australian citizen has been charged under Australian law for his alleged role in the conspiracy.

This case is being investigated by the FBI, and a number of other agencies in the U.S. and overseas.

ILC Dover opens homeland security test facility

ILC Dover, Frederica, opened a new facility that will be used to test technology and products for homeland security, as well as protection of subway tunnels and other city facilities.

The security component of the facility is funded by the Department of Homeland Security and will be used to test the Resilient Tunnel Plug technology.

Spin-off technologies for flood protection and mitigation will be tested in a second section of the facility which has been funded by [ILC Dover](#). The Resilient Tunnel Plug program is a Department of Homeland Security Science and Technology Directorate effort to provide security to transit systems as protection from flooding in the event of a terrorist attack.

The test facility is a full-scale model of a subway tunnel and was originally designed and built for DHS by West Virginia University for testing tunnel plug technologies. The initial test facility hardware was relocated to ILC Dover's Frederica facility where the development, construction and modification of the test facility was completed.

"In 2008, we were approached by the Department of Homeland Security's Science and Technology Directorate to help with an effort to support our

nation's security," said ILC Dover President Fran DiNuzzo. "They approached us with the idea of designing a large plug that would hold back 30 feet of water inside a tunnel in the unfortunate event of a terrorist attack. Since that time we have enjoyed a great working relationship with the team at the Department of Homeland Security and the result of these efforts is the Resilient Tunnel Plug security system that protects American lives and our infrastructure. In addition, following Superstorm Sandy in October of 2012, we were able to leverage lessons learned from this program and work with the City of New York to develop a series of novel Flood Protection Systems that can protect national

and international transit operations. New York City represents the first round of this business expansion with protection against the threats of flooding due to storm events and global warming."

"The creativity and ingenuity of our partners at ILC Dover, Pacific Northwest National Laboratory, and West Virginia University have developed and tested several prototypes of this unique inflatable tunnel plug technology," said DHS Under Secretary for Science and Technology Reginald Brothers. "Through their efforts and continued



Newark Post owner expands its Ohio newspaper holdings

The owner of the Newark Post is expanding its chain of newspapers and related websites.

Adams Publishing Group has purchased the *Athens News*, a twice-weekly in the same city where Adams owns the *Athens Messenger* daily newspaper in the city that is the home of Ohio University.

The two newspapers will operate separately, according to a story in the [Athens News](#).


Last spring, Adams purchased a large chunk of American Consolidated Media. The purchase included ACM Chesapeake papers that include the *Post*, *Cecil Whig*, *Elkton* and *Star Democrat* in Easton, Md.

Also part of the deal was the *Athens Messenger* and other Ohio papers, as well Minnesota and Wisconsin weeklies and small dailies owned by ACM.

The remainder of American Consolidated Media, small newspapers in Texas, Oklahoma and Texas, was sold to a company that controls Gatehouse

newspapers. Delaware Gatehouse papers include the *Dover Post*, *Middletown Transcript* and the *Community News*, Hockessin.

ACM had a brief and a rocky history that started with the purchase of community papers at hefty prices. That led to a heavy debt load piled up by its Australian owners with control of the company going to its lenders. Management focused on a “Digital First, Print Best” strategy while cutting staff and other costs as advertising sales fell. Since the spring ACM deal, Adams has added to those holdings with newspapers and related websites in southern Minnesota and northern Wisconsin. There have been few signs of major investments in media properties.

Adams has retained top managers and reportedly the staffs of the acquired newspapers. Adams, based in Minneapolis, is controlled by Stephen Adams, a reputed billionaire whose family holdings have included billboard companies, magazines, wineries and services for recreational vehicles. - *Doug Rainey*. *Rainey is former Editor of the Newark Post.*

Longwood Gardens will make \$90 million in major improvements to its Main Fountain Garden in Kennett Square, Pa. near the Delaware border. The fountain will close until 2017.

The investment, "New Heights: The Fountain Revitalization Project," will replace the 83-year-old fountains' systems with the latest technology, improve guest access to the garden, and add new elements that honor the original design by Longwood Gardens founder Pierre S. du Pont. Groundbreaking will begin in mid-October of this year and the Main Fountain Garden will reopen in spring 2017.

"New Heights is a part of our long-term commitment to delivering a world-class experience for all our guests." said Executive Director, Paul B. Redman. The project will feature:

- Restoration by specialists of the original limestone reliefs and fountains throughout the five-acre garden.
- Total replacement of the fountains' electric and plumbing infrastructure with 21st-century systems,



allowing the fountains to run more efficiently and for a significantly longer period during the year.

- New water choreography, which will include jets that project water 175 feet in the air - 45 feet higher than the current capabilities; the jets will also allow for more precise control of the water movement to create unique undulating, flexing, and spinning effects.
- Replacement of the fountain lighting system with energy-efficient LED lights, which will also allow the water choreography to take on a new range of colors.
- The re-opening of the elegant south wall, which has been closed to the public for the last 20 years,



containing a total of 20 wall-mounted fountains.

- The Grotto, entered from passageways on either side of the loggia, which lead to a vaulted central hall; at the center will be a circular water curtain wall and oculus that allows natural light to enter the space.
- A trellis bridge connecting to the Fountain Terrace allowing guests to look out over the surrounding gardens.
- A renovated pump house lobby, which will showcase the original pumps that powered the Main Fountain Garden from 1931 to 2014.

- An enhanced landscape that includes increased planting, enhanced horticultural displays, and expanded, fully accessible walking areas.

“Our founder Pierre S. du Pont created the Main Fountain Garden for the enjoyment and delight of his guests at Longwood. Over the past eight decades, they have become a beloved part of our grounds,” said Redman. “The Gardens and its Board of Trustees have been planning for the revitalization of these iconic fountains for many years now. We are preserving Mr. du Pont’s legacy and adding to it.” through beautiful new plantings, the creation of new spaces in which to relax and reflect, and improved accessibility so guests can walk freely among the fountains .”

Firms chosen for the project include;

Beyer Blinder Belle, an architectural firm specializing in historic preservation, will lead the renovation project and a team of local, national, and international designers. BBB will also take the lead on reimagining the existing architecture to accommodate a greater range of visitors and to improve visitor flow and access to different areas of the Garden.

West 8, a landscape architecture firm, will design the garden’s public spaces to harmonize with the original design and enhance the Main Fountain Garden’s horticultural elements, as well as creating new gardens that will be new amenities for Longwood’s guests.

Fluidity Design Consultants, a Los Angeles-based water feature design and engineering firm, will oversee the incorporation of state-of-the-art infrastructure to the fountains. The firm will also add new capabilities to control the water’s movement that will enhance Longwood’s Illuminated Fountain Shows.

du Pont personally designed the five-acre Fountain Garden, incorporating both French and Italian elements. The goal was to rival the fountains he had seen in Europe and at the 1893 World Columbian Exposition in Chicago.

Redman concluded, “New Heights is a part of our long-term commitment to delivering a world-class experience for all our guests. The project will ensure that our guests enjoy this iconic fountain collection for decades to come. Longwood will remain open throughout the Fountain Revitalization Project, with special one-time, summer programming and events to provide our audiences with exciting new cultural and horticultural experiences.”

Evraz to sell minority stake in US mills

Evraz North America, a part of the Russian steel company, has registered with regulators as it plans to spin off a 35 percent stake in the company. Evraz owns a steel mill in Claymont that was shuttered last year.



Evraz is based in London, but has the bulk of its holdings in Eastern Europe. It is facing pressures from Russian military actions in Ukraine that have resulted in sanctions. A major shareholder is Roman Abramovich, one of that nation’s “oligarchs.” who ended up controlling large pieces

Shire to pay penalty to state

Shire Pharmaceuticals will pay Delaware \$137,000 as part of a national settlement with state and federal governments to resolve allegations that

the company improperly marketed its drugs for off-label uses. The entire settlement totals \$56.5 million. The agreement settles charges that Shire, a Pennsylvania-based subsidiary of a British company launched marketing campaigns for Adderall XR, Vyvanse, Daytrona, Lialda and Pentasa, promoting the drugs for uses for which they had not received Food



and Drug Administration approval, according to a release from Attorney General Beau Biden. Delaware's \$137,000 payment will go to Delaware's Division of Medicaid and Medical Assistance, as reimbursement for previous Medicaid expenses that were incurred as a result of the drugs being used for off-label purposes.

As a condition for the settlement, Shire has entered into a Corporate Integrity Agreement

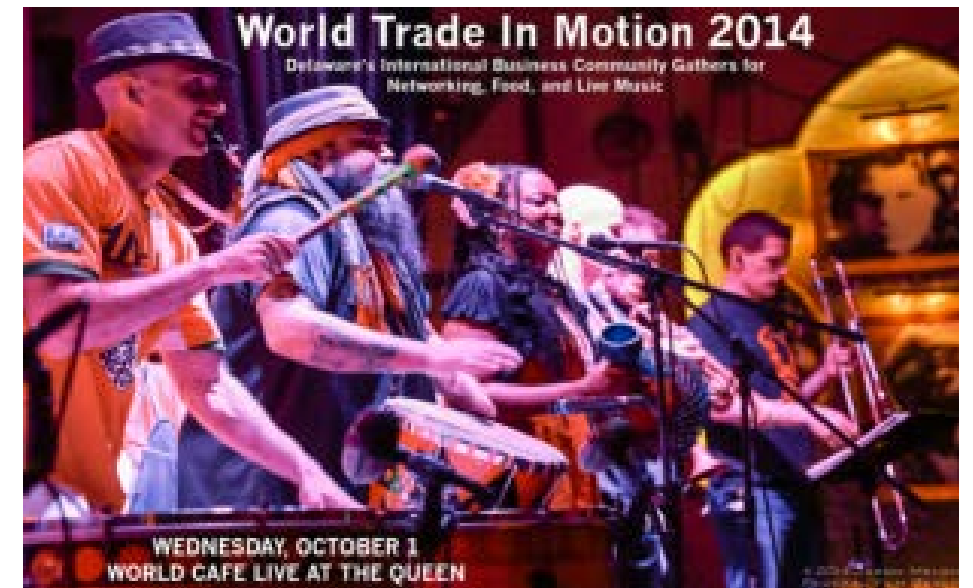
